Last year, domestic agricultural operators received record levels of agricultural support; however, in a still uncertain market and economic environment, it is crucial that they continue to have access to the support funds rightfully due to them this year. The session will look at what important changes farmers need to be prepared for in this year's unified electronic support application period. It also highlights the most significant changes to the EU Common Agricultural Policy (CAP) direct aid rules under each pillar. There will also be a discussion on the professional assistance available to beneficiaries in obtaining subsidies and the criteria used by the Hungarian State Treasury, acting as a paying agency, in conducting audits related to support payments.

### **Session II: Rural Development, Agricultural Financing: Big Opportunities**

The Ministry of Agriculture has set out a timetable for launching the long-awaited new calls for proposals under the EU-Hungarian co-financed Rural Development Programme. This session will outline the upcoming calls for proposals that agricultural businesses can anticipate in 2024, detailing the purposes and the respective amounts they can apply for. The experts will also explain how implementation, evaluation, and payment criteria are changing and what industry players need to do to submit successful proposals. Another important topic of the session will be how the macroeconomic environment, which is also a key factor for agricultural enterprises, can affect the financing possibilities of market players. As expected, the economy may return to a stable growth trajectory, and inflation has noticeably decreased; thus, borrowing conditions could become more favourable. However, the decline in profitability may complicate access to credit for agricultural market participants. The roundtable will discuss the financing situation of the Hungarian agricultural sector, how the interest and other conditions of agricultural loans may change, what new loan products and financing requirements banks are introducing to the market, and what subsidised or discounted agricultural loan schemes agricultural enterprises can expect.

The government is submitting a new 'producer protection' legislative package to parliament to improve farmers' bargaining positions against buyers. The session will present and analyse the new regulatory ideas on the agenda and highlight the new tools available to promote a more equitable income distribution in the fields of crop production and livestock. The new regulatory package aims to enable producers to achieve higher selling prices to cover their costs, which can provide them with greater production security than before.

## **Session V/A: Shock and a Way Out for the Food Market**

What are the most important legislative changes affecting food companies in Hungary this year, and how will the introduction of Extended Producer Responsibility (EPR) and Mandatory Deposit Return System (DRS) related to product packaging affect the management of companies in the industry in 2024?
